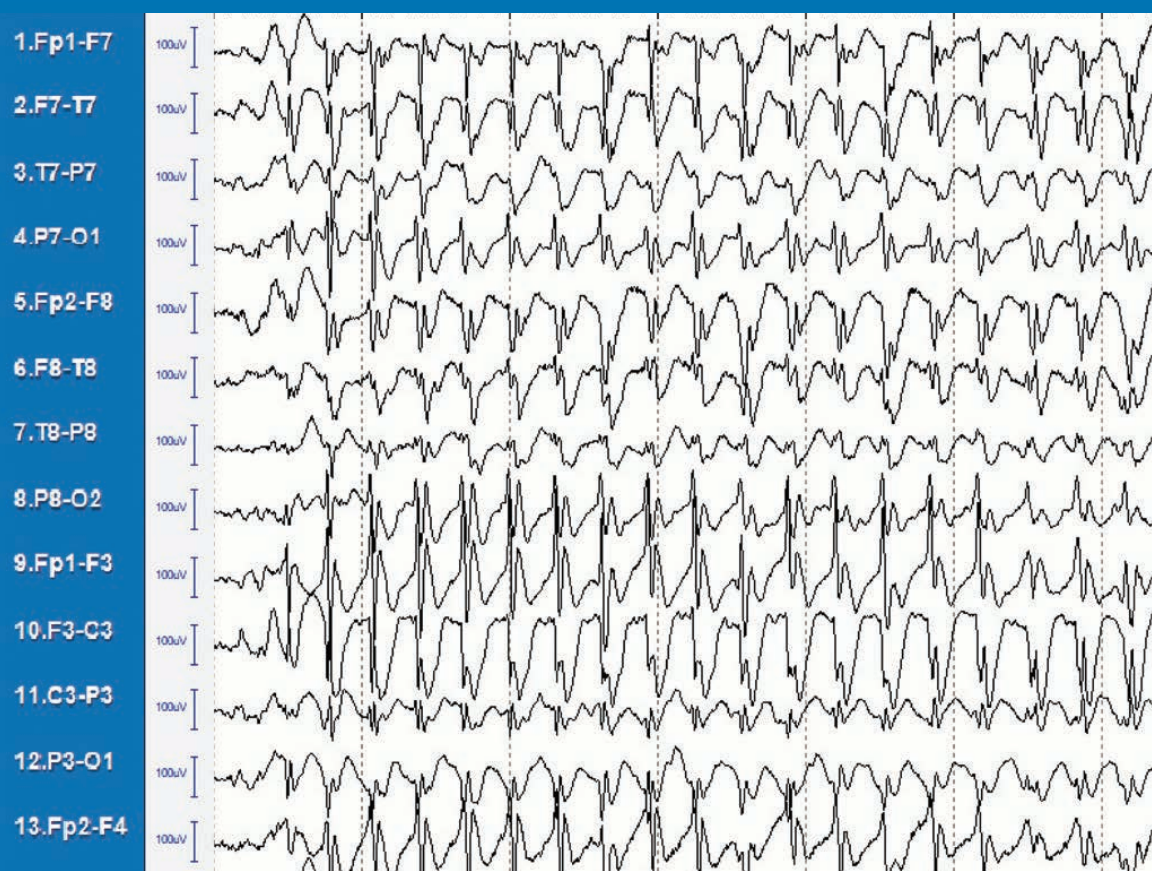

Welcome to the 16th Annual Cleveland Clinic Neurology Update. On behalf of the Neurological Institute at the Cleveland Clinic we would like to welcome you to our annual course and hope you find it valuable in your continuing care of patients with neurological disease. 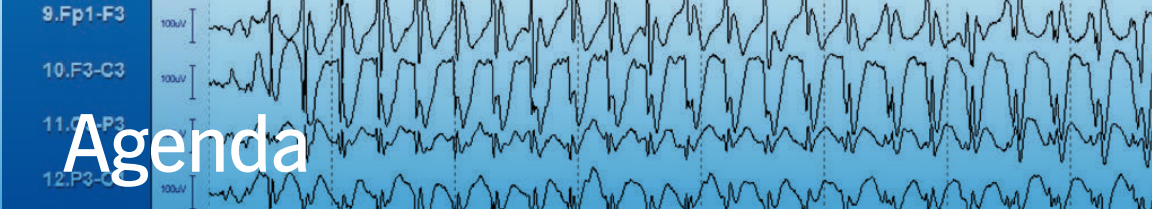

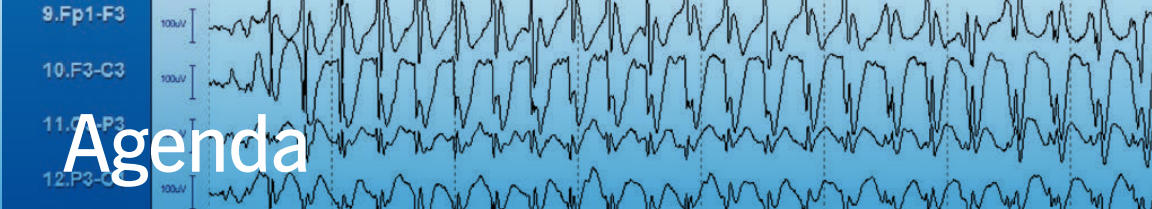

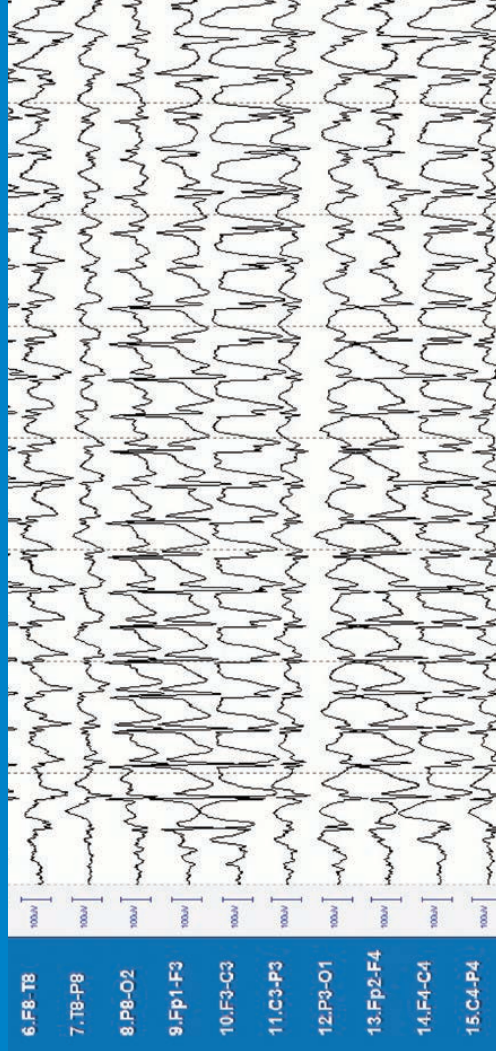
