On behalf of Cleveland Clinic's Digestive Disease Institute, we invite you to exhibit during the upcoming educational programs, to be held at the Margaritaville Hollywood Beach Resort on March 17 - 19, 2025.

Metabolic Surgery: Beyond Weight Loss

This in-person course will be held March 17, 2025, in conjunction with the Florida, Puerto Rico and Caribbean Chapter of the American Society for Metabolic and Bariatric. We anticipate 150 in-person participants and approximately 23 faculty.

22nd Surgery of the Foregut Symposium/

10th Congress of the International Society for Fluorescence Guided Surgery

This in-person course will also be held at the Margaritaville Hollywood Beach on March 18 - 19, 2025. We anticipate 100 in-person participants and approximately 25 faculty for this portion of the conference.

On March 17, in conjunction with the Florida, Puerto Rico, Caribbean Chapter of American Society for Metabolic and Bariatric Surgery, the course will present a full-day seminar, *Metabolic Surgery: Beyond Weight Loss*, on prevention, medical and surgical management of obesity. On March 18, in conjunction with the ISFGS, we will review new technology and techniques in surgery of the foregut and fluorescence guided surgery. On March 19, we will present interesting cases and abstracts submitted to the conference. This year's program will include an updated extensive review of artificial intelligence, machine learning and robotic surgery.

The course is designed for a national and international audience of physicians, surgeons, fellows, residents, nurses, and allied health professionals in the fields of fluorescence guided surgery, esophagus and diaphragm surgery, surgical endoscopy, general surgery, hepato-pancreatic and biliary surgery, as well as laparoscopic and bariatric surgery.
